Any use of the website, including the giving of donations, constitutes your consent to act according to these Terms and Conditions. Please read the Terms and Conditions carefully.

The 'Asher Ruach Bo' Amuta is recognized as a public institution in Israel under section 46 of the Income Tax Ordinance, in the United States under section 501(c)(3) of the US Internal Revenue Code, in the UK and in Canada.

 When making a donation with a credit card, the card will be checked with the credit company and the surfer (donor) will receive an immediate response regarding the status of the transaction and whether it was accepted or rejected.

The payment page is secured with the PCI DSS standard.

2. The 'Asher Ruach Bo' Amuta allows you to donate money through this site for the Amuta's purposes easily, conveniently and quickly. You can pay by credit card, bank transfer, BIT or telephone.

When making a donation, confirmation of the payment will be sent to the donor's email. Please make sure to input the email and telephone number correctly. Receipts will be sent by email.

3. Policy for canceling donations/transactions:

The person making the transaction will be entitled to contact the Amuta with a request to change the details of the charge or cancel a transaction.

It is possible to cancel the transaction within 30 days of the date on which the donation notice was sent by telephone or the donation transaction was made on the website, according to the Consumer Protection Law, 5741-1981.

The Amuta will make the requested change according to the policy in force at that time at the credit company. If the credit company will charge the Amuta a commission for the transaction, the person making the transaction will be charged that commission.
